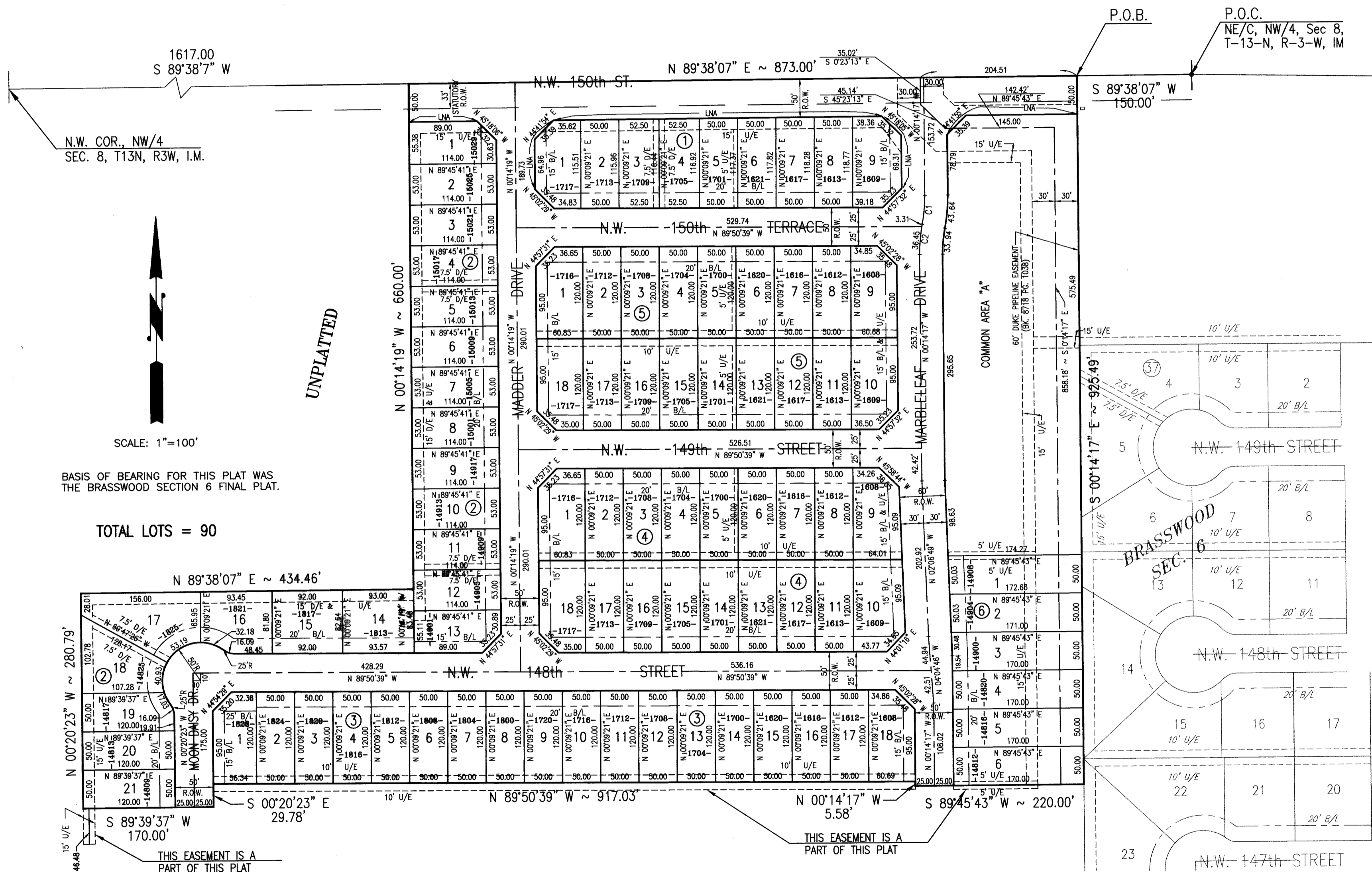
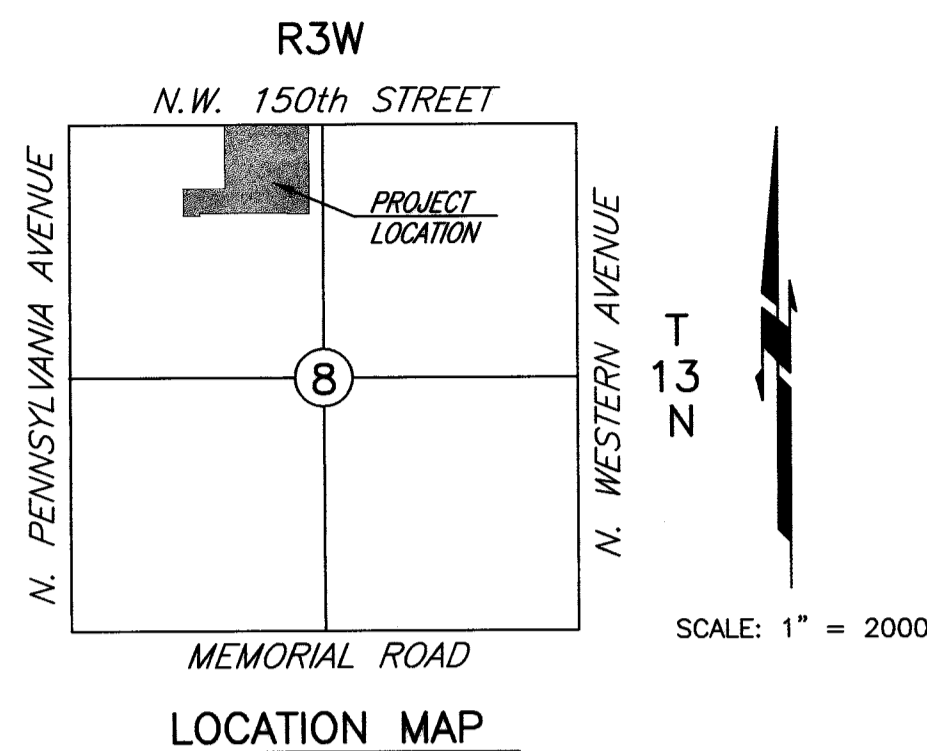
Legal Description

Being a part of the N.W. 1/4, Section 8, T13N, R3W, I.M., Oklahoma City, Oklahoma County, Oklahoma, and being more particularly described as follows:

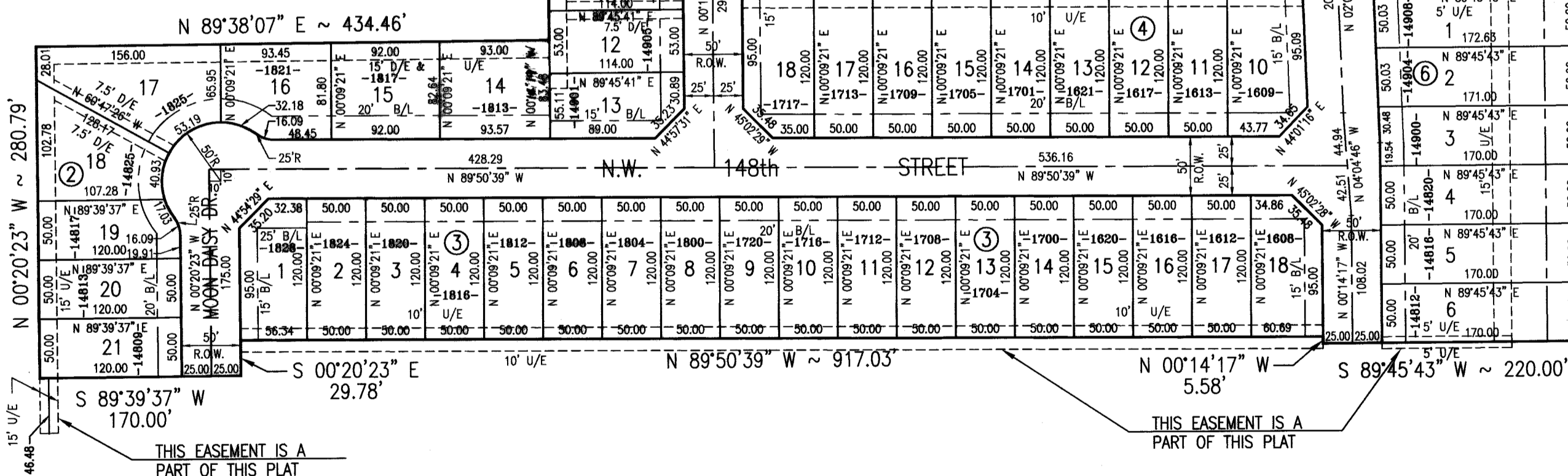
COMMENCING at the Northeast corner of the Northwest Quarter (N.W. 1/4) of said Section 8; THENCE South 89°38'07" West along the North line of said N.W. 1/4, a distance of 150.00 feet to the POINT OF BEGINNING;

THENCE South 00°14'17" East parallel with the East line of said N.W. 1/4, a distance of 925.49 feet; THENCE South 89°45'43" West a distance of 220.00 feet; THENCE North 00°14'17" West a distance of 5.58 feet; THENCE North 89°50'39" West a distance of 917.03 feet; THENCE South 00°20'23" East a distance of 29.78 feet; THENCE South 89°39'37" West a distance of 170.00 feet; THENCE North 00°20'23" West a distance of 280.79 feet; THENCE North 89°38'07" East a distance of 434.46 feet; THENCE North 00°14'19" West a distance of 660.00 feet; THENCE North 89°38'07" East along the North line of said N.W. 1/4, a distance of 873.00 feet to the POINT OF BEGINNING.

Said tract contains 21.04 acres more or less.

MAINTENANCE OF THE COMMON AREAS IN MARBLELEAF ADDITION SECTION 1 AND THE ISLANDS WITHIN THE STREET RIGHTS OF WAY SHALL BE THE RESPONSIBILITY OF THE PROPERTY OWNERS ASSOCIATION. NO STRUCTURES, STORAGE OF MATERIAL, GRADING, FILL OR OTHER OBSTRUCTIONS, INCLUDING FENCES, EITHER TEMPORARY OR PERMANENT, SHALL BE PLACED WITHIN THE COMMON AREAS SHOWN.

A SIDEWALK IN ACCORDANCE WITH CITY SPECIFICATIONS SHALL BE REQUIRED ON EACH LOT AT THE BUILDING PERMIT STAGE WITH INSTALLATION PRIOR TO THE ISSUANCE OF A CERTIFICATE OF OCCUPANCY. SIDEWALK WILL BE REQUIRED ALONG THE COLLECTOR, AND LOCAL STREET FRONTAGES ONLY.

ALL HOMES IN THIS PLAT TO BE CONSTRUCTED WITH CLASS "C" OR BETTER ROOFING MATERIALS.

TWO TREES SHALL BE PLANTED IN THE FRONT YARDS OF ALL LOTS WHERE THE GARAGE PROTRUDES BEYOND THE FRONT WALL OF A RESIDENCE.
